#### 1. Information collection and tracking

##### 1.1 When you visit a website

You can visit our website without giving away your personal information. Lutyens Advisory uses Google Analytics and Cookies in order to improve our service, user experience and analyse how the website is used. Aside from the approximate location (IP address), the information collected by Google Analytics is mostly anonymous traffic data including browser information, device information, language.

The collected information is used to provide an overview of how people are accessing and using the Lutyens Advisory website. It is not used for any additional purpose, such as to profile those who access our website.

##### 1.2 When you submit a CV to us

When you submit a CV to us we collect the personal data you give us to be used for the following purposes and collated with additional data obtained from publicly available data, data from interactions with you and with related third parties.

### 2. Recruitment

If you apply for a job with Lutyens Advisory, we will collect, process and store the information you have sent us for recruitment-related purposes, such as contacting you. Additionally, Lutyens

Advisory may keep your data for a period of time for the purpose of considering you for a different opportunity.

### 3. Information Security

Lutyens Advisory seeks to ensure the security of personal data. When Lutyens Advisory collects information about you, we also make sure that your information is protected from unauthorized access, loss, manipulation, falsification, destruction or unauthorized disclosure. This is done through appropriate technical and organisational measures.
